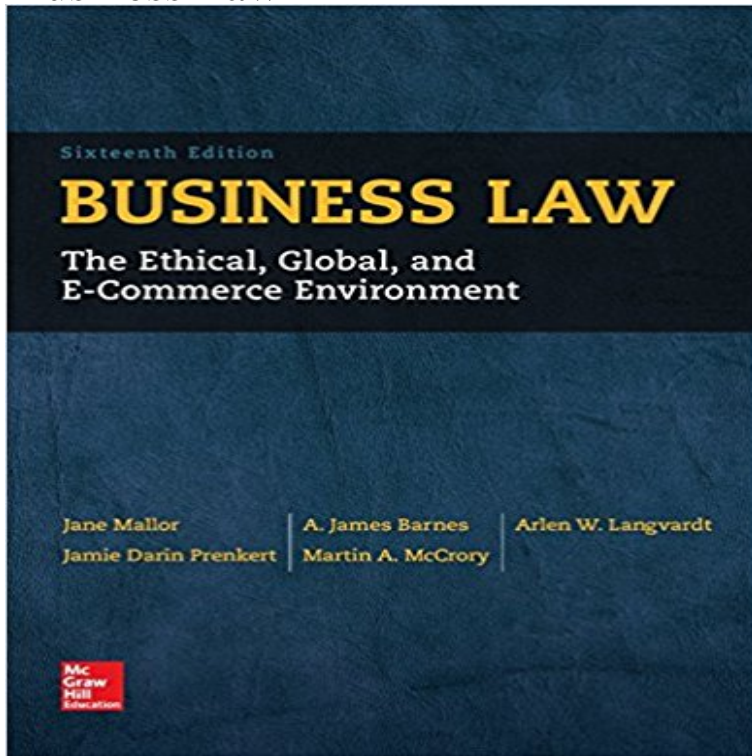


Business Law
